

Access to the Business Lounge of Henri Coanda International Airport Bucharest & Cluj-Napoca International Airport

Being the holder of the STAR Platinum Card from Banca Transilvania, you will enjoy free access to the Business Lounge in Henri Coanda International Airport Bucharest and Cluj-Napoca International Airport, for up to 4 hours, if you have done shopping (payments with the card to retailers) amounting to at least RON 300, during the last 3 months before accessing the services of the Business Lounge. If this condition is met, both the cardholder (account holder) as well as the users of the additional cards (designated holders) are granted free access.

The access is based on presenting the STAR Platinum card and the boarding pass.

The access is also allowed to the accompanying persons as follows:

- the first accompanying person is granted free access if the payment condition at retailers, amounting to a minimum value of RON 300 during the last 3 months, is fulfilled;
- starting with the second accompanying person, the access to the Business Lounge is possible based on fee, according to the fees shown in the table below.

If you exceed the 4-hour stay, you will be charged an additional cost per person/4-hour time interval, even if you leave the lounge earlier than this time interval, according to the fees shown below.

In the event of non-compliance with the payment condition of minimum RON 300 during the last 3 months prior to accessing the lounge, you will still be able to access the lounge, the costs for accessing the lounge being displayed below.

The amounts will be debited later on, from your STAR Platinum card account.

The card is not transferable, so we would like to draw your attention to the fact that, for accessing the Business Lounge, the card can only be used by the card's holder, who is also required to present his/her boarding pass. If you are the owner of two or more cards that offer this benefit, they can not be used at the same time to offer free access to the business lounge to a larger number of guests. Access is free of charge for the card holder and one guest, and starting with the second guest, the charge is made according to the information presented above, regardless the number of eligible cards issued on his name.

Additionally, as a Visa Platinum card holder, you have the Priority Pass card that grants access to you and your accompanying persons to the VIP or Business Lounges of the International Airports from abroad, for EUR 24/person/access (the number of accompanying persons is not limited). The amounts will be debited later on, from your STAR Platinum card account.
