

### THE DECISIONS ADOPTED BY THE ORDINARY GENERAL SHAREHOLDERS' MEETING BANCA TRANSILVANIA S.A. CLUJ-NAPOCA April 25<sup>th</sup> 2024

On the 25<sup>th</sup> of April the Ordinary General Shareholders' Meeting of Banca Transilvania took place at Calea Dorobanților Street, no. 30-36. The meeting was attended by shareholders and representatives of shareholders, accounting for 72.07% of the share capital, respectively 573,616,632 shares, thus the meeting was held in compliance with the legal and statutory requirements.

After the debates, the **Ordinary General Shareholders Meeting** adopted the following decisions:

# 1. Approval of the annual statutory IFRS financial statements for the 2023 financial year, in compliance with BNR's Order No. 27/2010 as subsequently amended, together with the Report of the Board of Directors and the Report of the Independent Auditor and other reports subject to an advisory vote.

(adopted with majority of votes, representing 72.04% of the capital share; the number of valid votes is 573,377,761, of which 547,736,801 votes **for** and 24,613,025 votes **against**; there were 1,027,935 **abstentions** regarding this item)

#### 2. Discharge of directors for the 2023 exercise.

(adopted with majority of votes, representing 72.04% of the capital share; the number of valid votes is 573,377,761, of which 566,416,217 votes **for** and 2,099,486 votes **against**; there were 4,862,058 **abstentions** regarding this item)



## 3. Approval of the revenue and expenditure budget and the investment plan for 2024 (business plan for 2024).

(adopted with majority of votes, representing 71.53% of the capital share; the number of valid votes is 569,318,138, of which 569,318,138 votes **for** and o votes **against**; there were o **abstentions** regarding this item)

4. Approval of the distribution of cash dividends from the profit for the year 2023, as follows: the amount of 1,000,000,000 lei from the net profit reserves for the year 2023, the total amount being granted as cash dividends. Approval of a gross dividend/share of 1.2521000331 lei.

(adopted with majority of votes, representing 72,04% of the capital share; the number of valid votes is 573,377,761, of which 573,377,761 votes **for** and 0 votes **against**; there were 0 **abstentions** regarding this item)

5. Maintaining the directors' remuneration for 2024, including the maximum cap of additional remunerations (fixed and variable) granted to directors and managers.

(adopted with majority of votes, representing 72,04% of the capital share; the number of valid votes is 573,377,761, of which 428,163,682 votes **for** and 141,153,891 votes **against**; there were 4,060,188 **abstentions** regarding this item)

6. Approval of the date of June 12<sup>th</sup>, 2024 as the registration date and of the ex date – June 11<sup>th</sup>, 2024, for the identification of the shareholders who will benefit from the results of the Ordinary GMS and to whom the effects of the Ordinary GMS Decisions are applicable.



(adopted with majority of votes, representing 72,04% of the capital share; the number of valid votes is 573,377,761, of which 573,377,761 votes **for** and 0 votes **against**; there were 0 **abstentions** regarding this item)

#### 7. Approval of June 26<sup>th</sup>, 2024 as the payment date for the dividend.

(adopted with majority of votes, representing 72,04% of the capital share; the number of valid votes is 573,377,761, of which 573,377,761 votes **for** and 0 votes **against**; there were 0 **abstentions** regarding this item)

8. Approval of the mandates for the Board of Directors and for its individual members to carry out the decisions adopted by the Ordinary General Meeting of Shareholders.

(adopted with majority of votes, representing 72,04% of the capital share; the number of valid votes is 573,377,761, of which 573,377,761 votes **for** and 0 votes **against**; there were 0 **abstentions** regarding this item)
