Banca Transilvania has signed, on the 3rd of April 2018, the necessary documents for the closing of the transaction regarding the acquisition of majority holding of 99.15% owned by Eurobank Group in the capital of Bancpost S.A. As a result of the transaction, BT will acquires holdings in the companies which are part of the Eurobank Group in Romania, namely ERB Retail Services IFN SA and ERB Leasing IFN SA.

Banca Transilvania has acquired Bancpost for EUR 178.67 million. As part of the transaction, BT has taken over a subordinated loan of EUR 80 million owed by Bancpost to its former majority shareholders. For ERB Retail Services IFN, Banca Transilvania has paid EUR 40.42 million, while for ERB Leasing IFN a total of EUR 6.79 million.
